What Is Funded

Regional Artist Project Grant funds provide financial support to a broad range of exceptionally talented visual, performing, literary and inter-disciplinary artists by funding a project that will have a significant impact on the advancement of their professional artistic career. The applicant may be an emerging or established artist and as a general rule should have completed some basic education in his/her art form. A deserving applicant will have a strong record of artistic accomplishment appropriate to the stage of his/her career. Regional Artist Project Grants are intended to fund a particular project that will **begin no earlier than January 1, 2019 and conclude by December 31, 2019**. While no specific limits have been established, awards may range from \$500 - \$2,500. Applicants may receive full or partial funding.

Artist representing all art disciplines are eligible to apply – please note eligibility criteria listed below.

Who May Apply

- Individual artists and small, unincorporated groups of collaborating artists are eligible to apply. Artist groups must have a formal partnership that furthers their careers in order to qualify such as a jazz quartet or a dance duo.
- Applicants must reside in one of the following counties for no less than one year immediately preceding application date:

- Applicant must be at least 18 years of age and cannot be currently enrolled in a degree or certificate program.
- Applicant does not plan on moving from North Carolina within the grant period.
- Award winners from the 2018 funding cycle cannot apply for 2019.

Examples of Fundable Projects

- **Promotion/Presentation:** the cost of producing a demonstration video for a composer, a video demonstration for a choreographer, a portfolio for an artist, editorial assistance for a writer, etc.
- **Travel:** costs for transportation, lodging and food associated with a specific art-related workshop, retreat or seminar.
- **Completion/Production:** the cost of purchasing materials for the completion of a significant new work of music, or the cost of renting a facility for the public presentation of a performance.
- **Training:** advanced study or coaching that will enhance the artist’s abilities.
- **Equipment:** the cost of purchasing equipment.

Evaluation Criteria

- Overall excellence of the applicant’s artwork and demonstration of exceptional talent.
- Serious professional commitment to art form.
- Contribution of the proposed project to the advancement of the applicant’s professional artistic development.
- Feasibility of the proposed project.

Application Process

All applications must be submitted to the Arts Council of Fayetteville/Cumberland County through our online portal which can be found at: www.theartscouncil.com/grants/regional-artist-project-grants or by going to our website, clicking the “Grants & Funding” tab and going to the “Regional Artists Project Grants” page.

Application Requirements:

An application **without all required attachments is incomplete** and will not be presented to the grants panel. All applications **MUST** be submitted through our online grants portal by Thursday, October 11th at 11:59 PM.

Narrative (required) - The narrative is broken down into the following questions, all of which must be answered for an application to be submitted:

Artistic Questions:

1. Please provide an artist's statement. The statement should be a general introduction to your work, and describe what you create and why you create it.
2. What are the primary influences upon your work as an artist? Influences may include (but are not limited to) the work of other artists or sources of inspiration outside of the arts.
3. What are both your short-term and long-term artistic goals?

Project Questions:

1. Please describe your proposed project and provide any details that may relate to your provided budget, i.e. what you want to do, who will be involved, etc.
2. What is the proposed timeline for your project? How will you accomplish this project? Be as detailed as possible.
3. How will this project assist with your short-term and long-term artistic goals provided above?

Budget – (required) Provide your Project Budget (both Expenses and Income). For your Project Expenses, please be sure to list each expense as its own line item. Be as specific as possible.

Budget support – (required) Provide support information for your budget that clearly displays the cost of each line item, i.e. screenshots or web addresses showing equipment costs, quotes from suppliers, brochures from conferences, etc.

Artistic Resume (required) – Your artistic resume should include education, exhibitions/performances, publications, commissions and honors.

References (recommended) – Letters of Reference are not required but are preferred. All Letters of Reference should be on letterhead and signed with contact information. References should be recent and from individuals familiar with your work and/or project. References should be professional recommendations and not personal recommendations. You may provide **no more** than three letters.

Work Sample – (required) You must submit **current** work samples. We typically define current as the last 3-5 years. **If work samples are not included, your application will not be presented to the panel.** Your work sample should pertain to your grant request. For example, if your project relates to fiction, submit a sample in the genre.

Dance: Recorded performance (video, no longer than a 5 minute clip).

Drama: Recorded performance (audio or video, no longer than a 5 minute clip).

Playwright: Up to 12 pages of manuscript. You may include a copy of a recorded performance (audio or video, no longer than a 5 minute clip).

Music: Up to three recorded performance (audio or video, each no longer than a 5 minute clip).

Literature: Up to 12 pages of manuscript

Composers: Up to 3 sample scores and recorded performance (audio, no longer than a 5 minute clip).

Visual Arts: Between 5 and 10 images of your work. All images must include a description that includes the date of completion, medium and size of work.

For video and audio work samples: Submit YouTube/online links. Please provide a brief description of each work sample including the date & location of performance, title of piece, name of artist performing, name of creator/composer/choreographer/etc. Please indicate if the sample was professionally mastered. You may also submit reviews, programs, and catalogs.

All completed Regional Artist Program Grant applications will be first judged by discipline-based artists and/or art educators on the criteria listed. Then a multi-county panel comprised of professional artists, art educators/administrators and/or arts advocates review the applications and the judges' evaluations and allocates funds for selected projects. Grant recommendations require approval by the Board of Trustees of the Arts Council of Fayetteville/Cumberland County.

Incomplete applications will not be presented to the panel. Late applications will not be accepted.
